20 The Grand Jury Charges:

21 COUNT ONE

22 That beginning on a date unknown but at least by on or about February 1,
23 2011, and continuing until on or about November 2, 2011, in the Eastern District
24 of Washington and elsewhere, JARED J. KYNASTON, SAMUEL M. DOYLE,
25 COREY E. MOBLEY, PETER M. MAGANA, BRICE C. DAVIS, JAYDE D.
26 EVANS, and TYLER S. McKINLEY, Defendants, named herein, and others
27 known and unknown, did knowingly and intentionally combine, conspire,
28 confederate and agree together with each other and with other persons, both
known and unknown, to commit the following offense against the United States, to
wit: Manufacturing One Hundred (100) or More Marijuana Plants, a Schedule I

1 controlled substance, in violation of 21 U.S.C. § 841(a)(1), (b)(1)(B)(vii), all in
2 violation of 21 U.S.C. § 846.

4 COUNT TWO


5 That on or about November 2, 2011, in the Eastern District of Washington,
6 JARED J. KYNASTON, SAMUEL M. DOYLE, COREY E. MOBLEY, PETER
7 M. MAGANA, BRICE C. DAVIS, JAYDE D. EVANS, and TYLER S.
8 McKINLEY, knowingly and intentionally manufactured one hundred (100) or
9 more marijuana plants, a Schedule I controlled substance, in violation of 21 U.S.C.
10 § 841(a)(1), (b)(1)(B)(vii).


11 FORFEITURE ALLEGATION

12 The allegations contained in Counts 1-2 of this Indictment are hereby
13 realleged and incorporated by reference for the purpose of alleging forfeiture
14 pursuant to 21 U.S.C. § 853. Pursuant to 21 U.S.C. § 853, upon conviction of an
15 offense in violation of 21 U.S.C. §§ 841, 846, the defendants, JARED J.
16 KYNASTON, SAMUEL M. DOYLE, COREY E. MOBLEY, PETER M.
17 MAGANA, BRICE C. DAVIS, JAYDE D. EVANS, and TYLER S. McKINLEY,
18 shall forfeit to the United States any property constituting, or derived from, any
19 proceeds obtained, directly or indirectly, as the result of such offense, and any
20 property used, or intended to be used, in any manner or part, to commit, or to
21 facilitate the commission of, the offense.
