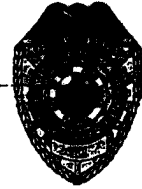

On Saturday December 22, 2012 at approximately 12:43 pm the West Palm Beach Police Department Emergency Communications Division received a 911 call of a shooting in the 4700 Block of South Olive Avenue in the City of West Palm Beach, Palm Beach County.

An eye witness to the murder told the emergency operator that a black male had just shot a female who was riding a bicycle; the black male fled the area on foot. The victim was identified as Amaria Grant, black female 12/10/1971. Ms. Grant died as a result of multiple gunshot wounds at the scene.

During the investigation Rupert O'Neil Harty black male 10/18/1981 was developed as a suspect in the murder of Ms. Grant.


On February 7, 2013 Rupert Harty was arrested by the West Palm Beach Police Department on an unrelated charge. Rupert Harty was interviewed by detectives at the West Palm Beach Police Department. Post Miranda Rupert Harty confessed to the killing of Ms. Grant. Rupert Harty told investigators on December 22, 2012 he was sitting at his residence, when he heard a voice tell him to go kill someone. Rupert Harty stated he drove in his taxi cab for approximately twenty minutes until he reached the area of the intercostal waterway in the City of West Palm Beach. Rupert Harty stated he parked his taxi cab on a side street and walked up to Ms. Grant as she was riding her bicycle. Rupert Harty stated when he approached Ms. Grant he pulled out his 9mm handgun and shot her in the head. Rupert Harty also stated as Ms. Grant was falling to the ground he shot her twice in the chest. After shooting Ms. Grant Rupert Harty said he fled back to his taxi and drove home.


The eye witness account of the murder of Ms. Grant was corroborated by Rupert Harty's Post Miranda statement.

Based on the facts set forth, your affiant has probable cause to arrest RUPERT O'NEIL HARTY for one count of First Degree Murder with a firearm in violation of F.S.S. 782.04(1)(A), for the murder of AMARIA GRANT.
